### Patricio Martínez Llompart



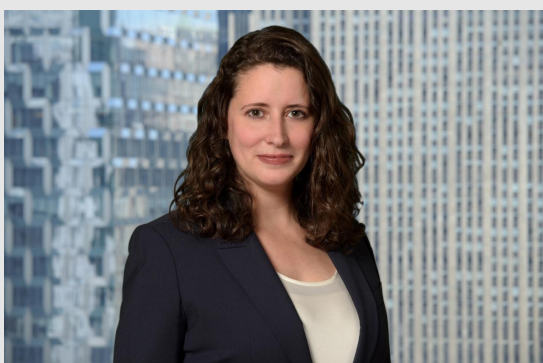
